2.	A health check must be performed on Puppy by a licensed veterinarian within 72 hours of purchase, otherwise Puppy's 2-year health guarantee is null and void. The health check must include an exam, any age appropriate vaccinations, and a
	fecal test. The official documentation of the vet's findings must be sent to Seller within 24 hours of visit, otherwise the 2-year health guarantee is null and void.

4.	Breeder does not guarantee against IVDD since the Dachshund breed is prone to back issues
5.	Breeder does not guarantee against CDA in dilute dogs or dilute carriers.
